The annual membership fee is due with this application and is nonrefundable. This fee provides membership for one year from the date payment is made. Renewal fees are due upon anniversary date to **RC Photo Club** with a **30-day grace period**.

Club Meetings, Outings, Workshops, and Volunteer Events Release Assumption of Risk, Waiver of Liability, and Indemnification Agreement

As a member of the RC Photo Club, Inc., (hereinafter referred to as the "Club"), I understand that participating in any Club meetings, outings, workshops, and volunteer events (hereinafter referred to as "Club activities") is potentially hazardous and that I should not participate unless I am medically and physically able. In consideration of the acceptance of this entry, I assume full and complete responsibility for any injury, accident, or loss of property which may occur while I am traveling to or from Club activities, or while I am at Club activities. I am also aware of and assume all risks associated with participating in Club activities, including but not limited to falls, contact with other participants, getting lost, effect of weather, traffic, and conditions of the road.

I further understand that Club activities may present inherent risk of personal injury or sickness, such as tripping, falling, injury by falling rocks, getting lost, traveling in rough terrain, possible creek crossings, attack by wild or stock animals including horses and cattle, forces of nature such as lightning strikes, absence of prompt medical attention if needed, inadequately marked trails, hiking injuries, illness due to impure water or tainted food or drink, and travel by automobile or other conveyance.

I, for myself, my family, and my heirs and executors, hereby waive, release, and forever discharge the event organizers, sponsors, promoters, the Club and each of its officers, board members, trip organizers, agents, representatives, heirs and assignees, and all other persons associated with Club activities, all liabilities, claims, actions, or damages that I may have against them arising out of or in any way connected with my participation in Club activities. I understand that this waiver includes any claims, whether caused by negligence, the action or inaction of any of the above parties, or otherwise.

The undersigned acknowledges that the RC Photo Club, Inc., neither insures Club members nor provides insurance covering any injury, health care problem, property loss, or other need during the Club activities. Insurance is the sole responsibility of the Club members.

The Club and each of its officers, board members, general members, trip organizers, agents, representatives, heirs and assignees, and all other persons associated with Club activities shall not be liable for any injury, loss, or damage arising out of or in connection with participation in any Club activities, without limitation, injury to person or property, or consequential or incidental damages, whether caused by acts, errors, or omissions of trip organizers, trip leaders, guides, outfitters, or other providers associated with Club activities.

This Assumption of Risk, Waiver of Liability, and Indemnification shall remain in effect for the duration of the undersign's membership, renewing annually upon paid membership renewal, until a time that the membership has expired & the member no longer wishes to renew his/hers membership.
